### London's Air Quality

The capital now has three active vehicle emissions standards to improve air quality and the health of residents, businesses and visitors:

- **Congestion Charge** - which operates in central London every day of the week except Christmas Day.
- **Ultra Low Emission Zone (ULEZ)** - which is expanding from 25th October 2021 to create a single larger zone up to, but not including, the North and South Circular Roads. This charge is focused on cars, motorcycles, vans, minibuses and other specialist vehicles, and operates 24 hours a day, every day, bar Christmas Day.
- **Low Emission Zone (LEZ)** - which covers most of Greater London, operates 24 hours a day, every day of the year, and focuses on buses, coaches and heavy goods vehicles.

### Ultra Low Emission Zone (ULEZ) costs

Cars, motorcycles, vans and other specialist vehicles (up to and including 3.5 tonnes), and minibuses (up to and including 5 tonnes) will either need to meet the ULEZ emissions standards, or pay a **£12.50 daily charge** when driving within the expanded ULEZ zone.

## London's Air Quality

This charge is focussed on cars, motorcycles, vans, minibuses and other specialist vehicles, and operates 24 hours a day, every day, bar Christmas Day.
- **Low Emission Zone (LEZ)** - which covers most of Greater London, operates 24 hours a day, every day of the year, and targets the most polluting heavy diesel vehicles.

## Ultra Low Emission Zone (ULEZ) and Congestion Charge

Cars, motorcycles, vans and other specialist vehicles (up to and including 3.5 tonnes), and minibuses (up to and including 5 tonnes) will either need to meet the ULEZ emissions standards, or **pay a £12.50 daily charge** when driving within the expanded ULEZ zone. **If you drive into central London on any day of the week (except Christmas Day) within the Congestion Charge zone and during charge hours, you will also need to pay the Congestion Charge.**

Below is a breakdown of the ULEZ and Congestion Charge costs that may be incurred, based on usage per week. If your vehicle is not ULEZ compliant, see our [Resident](#) and [Business](#) Guides for next steps on actions you can take to meet the standards.


### Assumptions

- Christmas Day exemption relies on the vehicle user using the car on Christmas Day as one of their times per week
- All charges have been rounded to the nearest pound

### Exemptions and Discounts

- Some residents or businesses may be able to apply for an exemption for at least a temporary discount to the ULEZ and the Congestion Charge. Examples include if you are disabled person, a person that works in specified occupations, or drive a zero emission vehicle.

### Ultra Low Emission Zone (ULEZ) and Low Emission Zone (LEZ)

The Low Emission Zone (LEZ) was set up to encourage the most polluting heavy diesel vehicles driving in the London to become cleaner. It covers most of Greater London and operates 24 hours a day, every day of the year. The daily charges are:

- **£100 for vans or specialist diesel vehicles** (over 1.205 tonnes unladen weight up to 3.5 tonnes gross vehicle weight) or minibuses (up to 5 tonnes) which do not meet Euro 3 standards - see table 1
- **£100 for HGVs, lorries, vans and specialist heavy vehicles** over 3.5 tonnes as well as buses/minibuses and coaches over 5 tonnes which do not meet Euro VI (NOx and PM) standards, but meet Euro IV (PM) - see table 1
- **£300 for HGVs, lorries, vans and specialist heavy vehicles** over 3.5 tonnes as well as buses/minibuses and coaches over 5 tonnes which do not meet Euro IV (PM) - see table 2

Some vans, if not compliant with LEZ and ULEZ, will need to pay **both** charges. All vehicles will need to pay the Congestion Charge if visiting the Congestion Charge Zone. Please visit [this table](#) to see if you need to pay the ULEZ charge in addition to the LEZ.

The tables on page 2 show the costs that may be incurred if your vehicle is not compliant for the LEZ, based on the usage per week. This has been broken down into those that need to pay the £100 charge and the £300 charge.
