The total number of visitors to Fitzrovia BID for the last 52 weeks is 32,966,842 which is 93.1% up on the previous year.

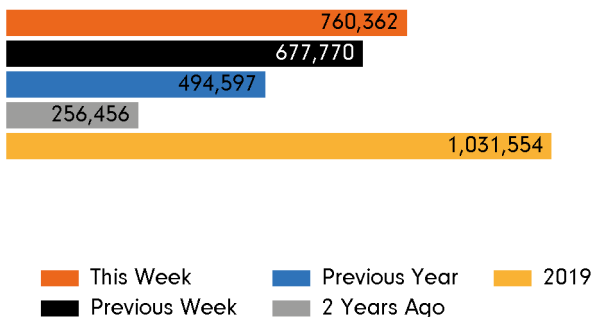
The total number of visitors for the year to date is 17,525,120 which is 113.6% up on the previous year.

The total number of visitors to Fitzrovia BID in week commencing 26 June 2022 was 760,362.

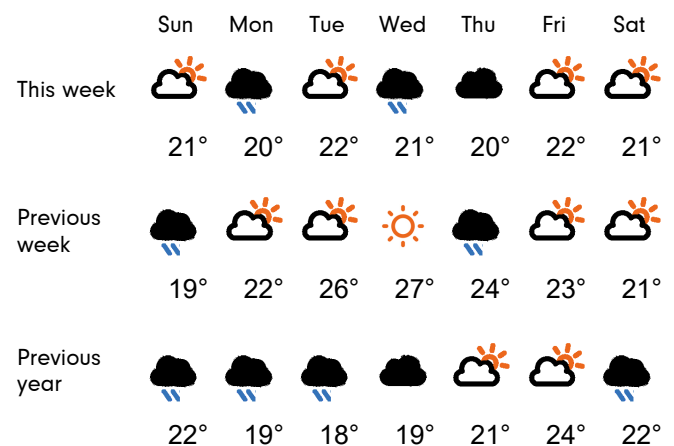
The busiest day in week commencing 26 June 2022 was Friday with 123,222 visitors.

The peak hour of the week was 17:00 on Tuesday 28 June 2022 with footfall of 10,048.

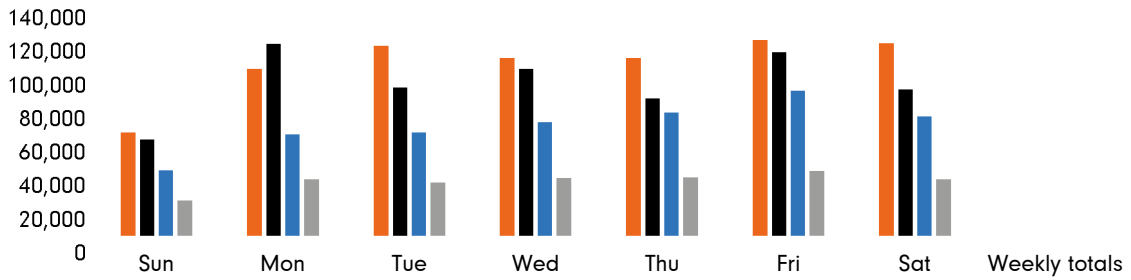

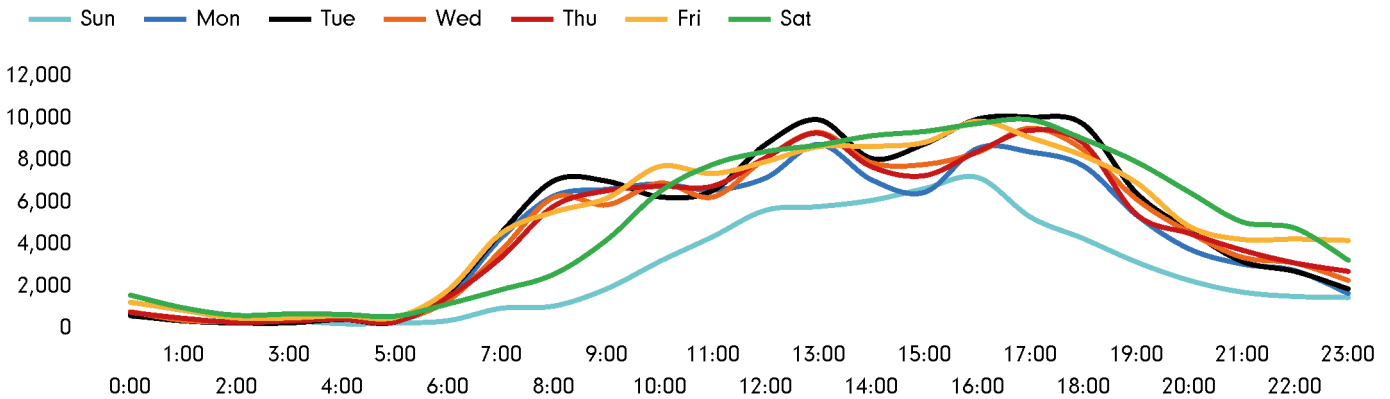

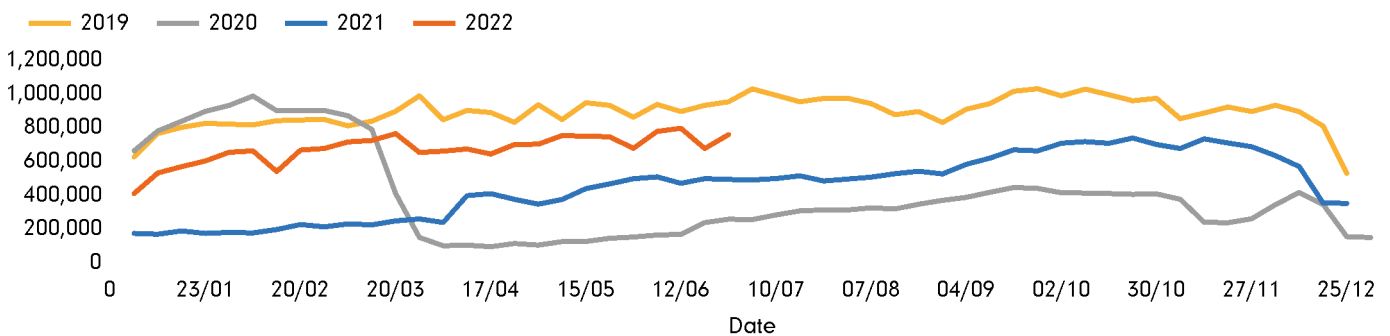

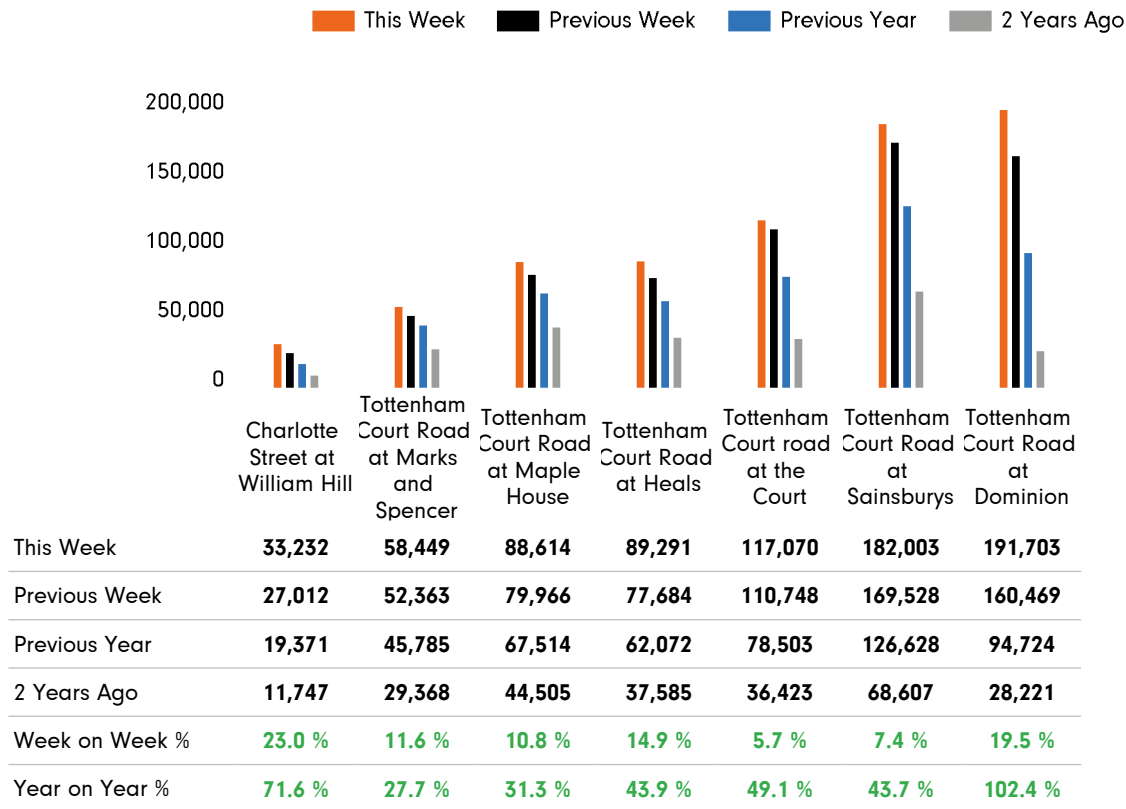

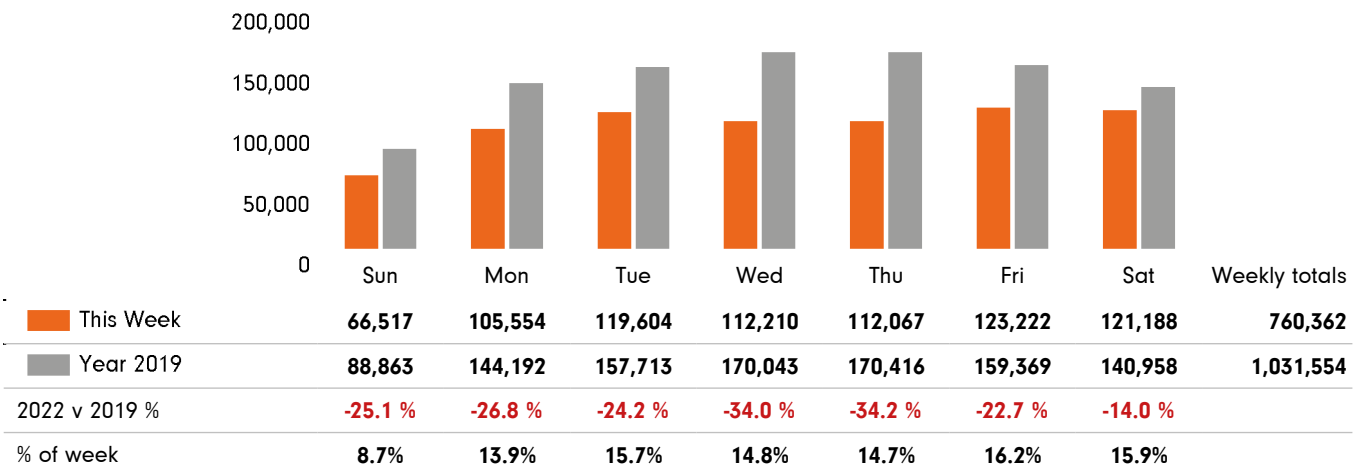
