The total number of visitors to Fitzrovia BID for the last 52 weeks is 35,372,137 which is 78.6% up on the previous year.

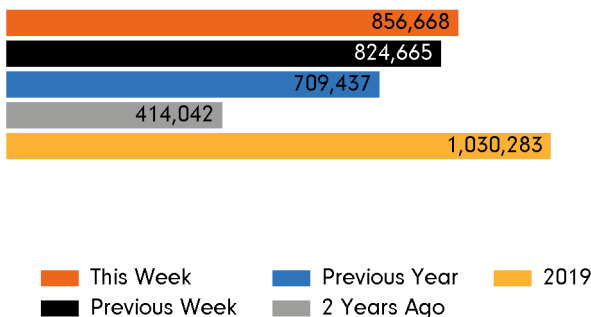
The total number of visitors for the year to date is 27,775,517 which is 73.1% up on the previous year.

The peak hour of the week was 13:00 on Thursday 6 October 2022 with footfall of 13,725.

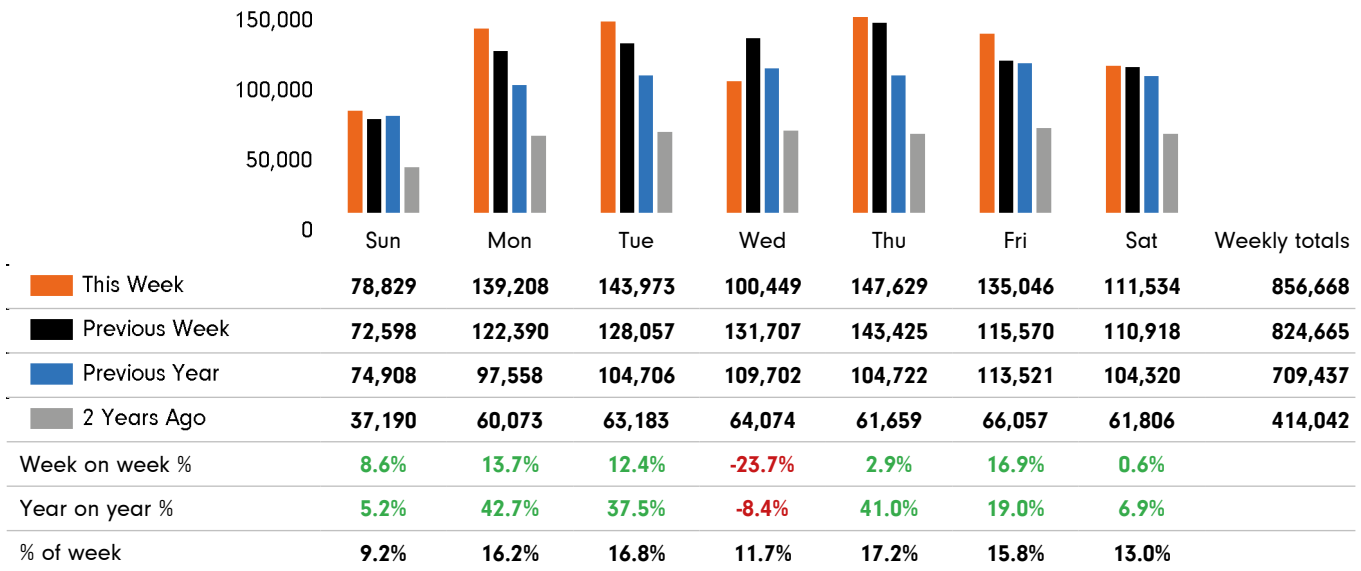

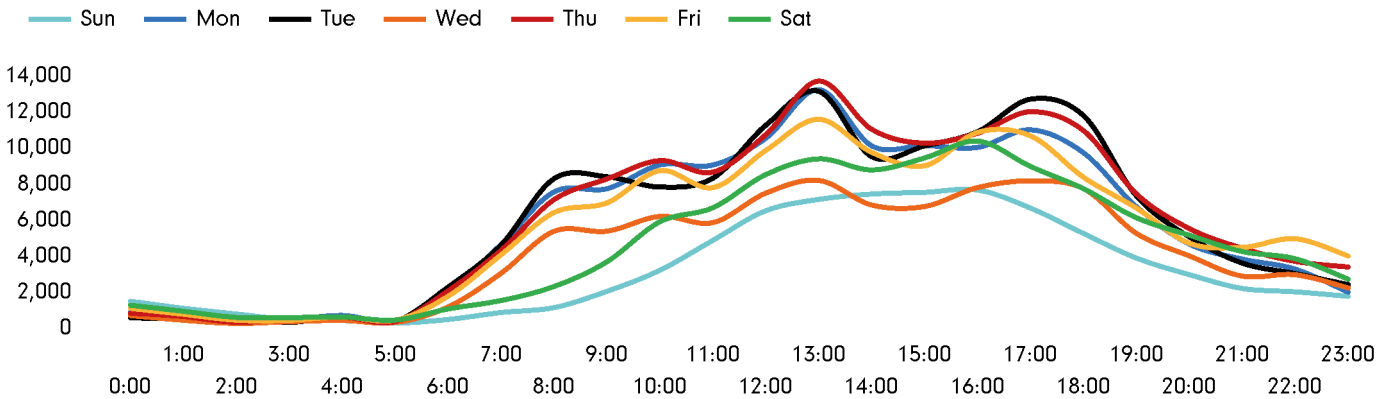

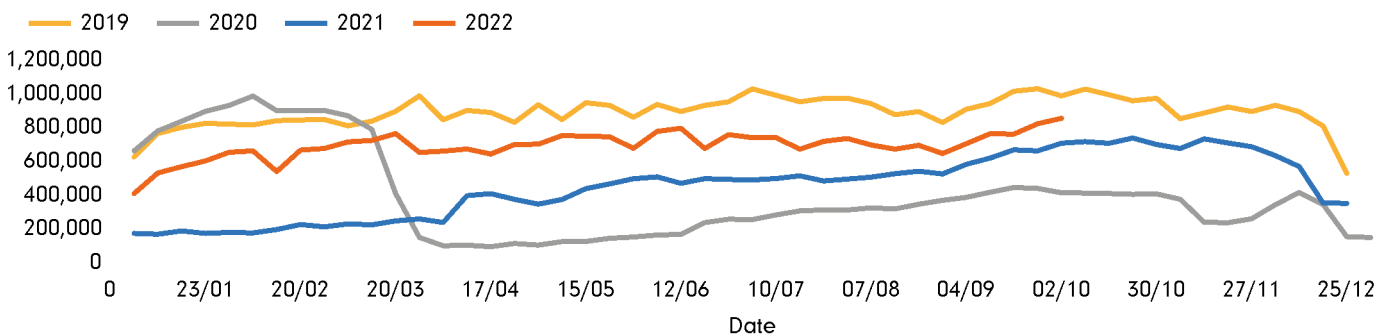

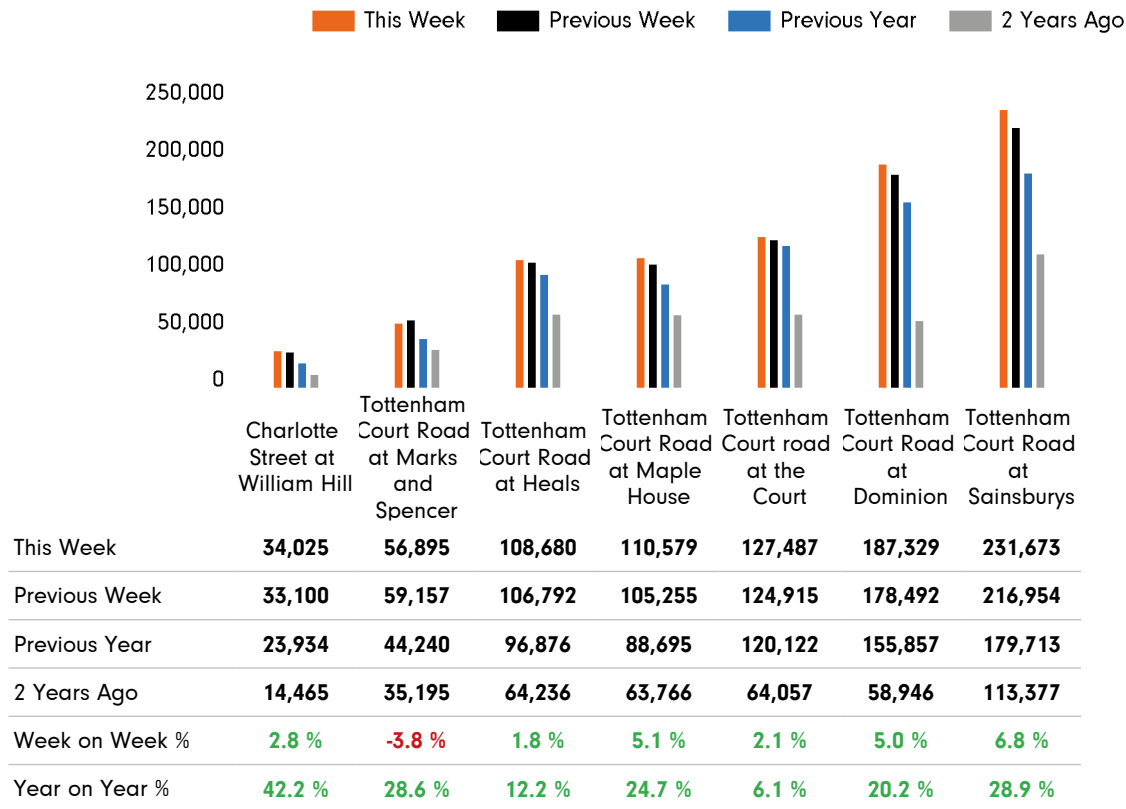
## Footfall by hour

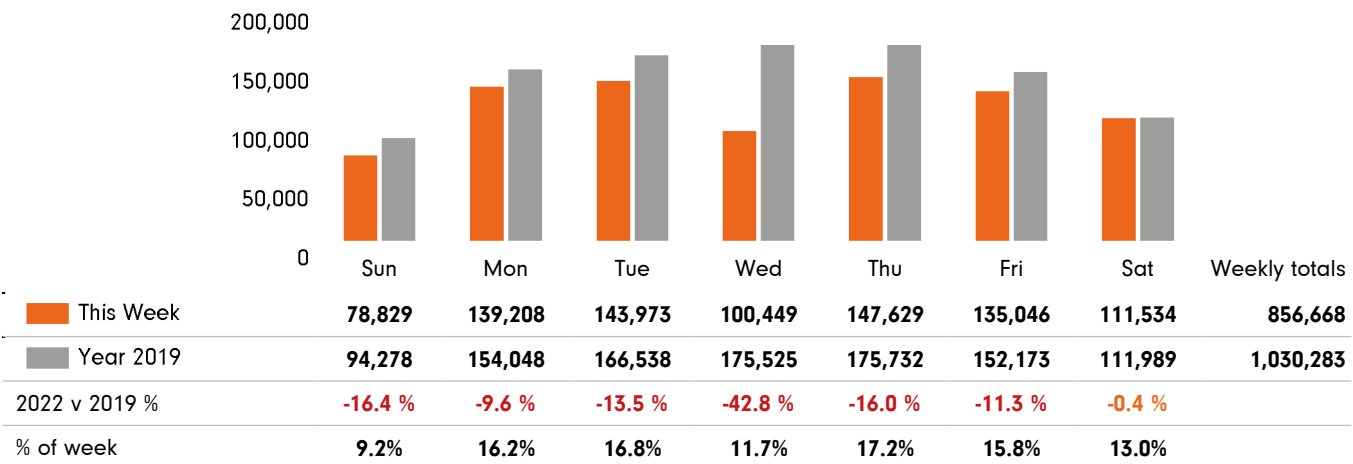
